wedding & event flowers

We love to work closely with our clients from start to finish, ensuring your vision is brought to life by our florals. We believe stunning floral designs are what create such beautiful backdrops for your day.

As florists, the team have a natural & romantic style, inspired by the textures and colours of the beautiful flowers we work with. Whether elegant and blousy, or structural and striking, the flowers we select together and the colour palette pairings shape the entire aesthetic.

Subsequent to filling out the contact form on our website, we begin to design a mood board ready for your consultation. Following the consultation, we design your wedding proposal to provide a visual guide of your flowers, with an attached quotation.

Please note that we ask that we are the sole providers of floral styling for your wedding/event (fresh, dried, and faux) as we design your florals to create a cohesive look that complements the venue and your theme.

There is no minimum spend for 'intimate' wedding packages and events, and a minimum spend of £1000 for full service weddings.

These are based on seasonal florals in your selected style and colour palette, allowing for abundance of florals but are a starting price so may be adjusted based on flower choices and the size of the piece.

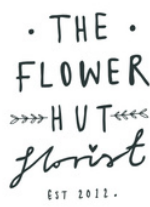

Wedding & Event Terms & Conditions

Thank you for your enquiry.

Here are our terms & conditions for booking your wedding & event flowers with us.

We are a professional & friendly team and have created our terms and conditions to clarify our services to you from your initial consultation, to creating & delivering your beautiful designs for your wedding or event. If you have any questions please let us know.

On receipt of your completed consultation form we will arrange your initial complimentary consultation. We always love to meet our clients in person but also understand that some of our clients live further away so of course we can have a phone or zoom consultation if you prefer.

Following our meeting we will design & create your wedding flower proposal based on our discussions. By booking a consultation you are agreeing to our terms & conditions.

Our floristry style is very natural and focused on beautiful fresh florals and embracing the seasons. We are working very hard towards sustainability & creating stunning florals that represent our style which we feel creates a more cohesive floral styling for our clients. With this in mind, we now ask that we are the sole supplier of flowers & no longer work alongside other flower providers to avoid any conflict of interest, including DIY wedding flowers, faux flowers, & flowers/foilage provided by an event stylist. Please do not hesitate to contact us if you have any questions.

We design our proposals uniquely to each wedding or event, allowing for the style, size & type of each design and the quantity of flowers required, including any specific flower choices that you would like included (subject to seasonal availability) without compromising on our clients' expectations. Our proposals will include a full itemised breakdown including delivery and set up fees as required. We do not automatically allow waiting time to move our designs between locations however this fee can be included on request. An additional site visit or pre-wedding consultation is included in your booking however, any additional meetings required may be chargeable.

Please note that it is the responsibility of the recipient to ensure that their flowers are kept cool and hydrated as instructed, following our set up. The Flower Hut are not responsible for damages to flowers transported by the client or damaged once they have left The Flower Hut's care.

We ask that any enquires regarding your flower order must be made within one hour of delivery or collection; it is the responsibility of the recipient to care for the flowers following our care instructions.

The Flower Hut cannot be held responsible for any breakages. All button holes and corsages are worn at the recipients own risk. Please note magnets should not be worn by anyone with a heart condition or pace maker. Flowers and plants can be harmful and must not be consumed; it is the recipient's responsibility to ensure they are kept out of the way of young children.

We guide you with our proposal however * Flower prices are estimated due to the possible price fluctuation during the year which are out of our control. Flower choices & accessories may vary if unavailable.

Flowers are a natural product & may differ in both colour & size; on occasions a specific flower variety may be unavailable. If this occurs, we reserve the right to substitute one flower type for another. We will endeavour to work within the ordered style, using flowers to the same or higher value.

We will always try to accommodate changes up to one month before your event date however we are unable to accept reductions in your order once your booking fee has been paid & the date secured with the exception of where final design confirmation is required.

The Flower Hut cannot be held responsible if delivery fails due to circumstances out of their control including an extreme weather conditions, act of god, crime, transport issues etc (sorry we have to cover all eventualities) but will of course do our best!

A £200 booking fee is payable (a smaller fee for smaller orders) on acceptance of our proposal to secure the date, with the balance payable two months prior to your event date. If you would like to change anything we ask that this is submitted to us in writing.

We have had to include the following to protect our business as once your booking is confirmed it reduces our capacity to fulfil other bookings etc.

If you wish to reschedule your event date we will do our best to transfer your booking, however if we are unavailable or you choose to cancel, the booking fee will be non-refundable.

Cancellation Charges

Cancellations of the booking if cancelled within 7+ months - fee non-refundable

If cancelled within six months - fee non-refundable plus 50% of the balance

Cancellation within two months of the event date the full balance will be required.

Cake Flowers

We are happy to include fresh flower stems only as part of your order for your cake designer. However, for food hygiene regulations we do not dress the cake on their behalf & please note some flowers and greenery are toxic and therefore are not suitable for use as a cake decoration. We will require the cake designer to confirm the quantity & variety of flowers that they require & we cannot be liable for any contamination to your food product that may arise from their misuse. We recommend that your cake supplier liaise directly with us to confirm details to avoid any miscommunication.

We ask that all hired items are to be returned to The Flower Hut the next working day after the event date unless otherwise agreed, with all breakages paid for in full. A breakages deposit will be charged for hired items where applicable and will be refunded once hired items have been returned.

We will send your updated order confirmation & our full T&Cs & payment details on acceptance of our proposal.

We are delighted to meet our clients & take the time to prepare each individual quotation & respectfully ask if you could please confirm whether or not you wish to proceed.
